How can we fund climate action?

Material:	Slides
Timing	10 minutes
Aim:	To make learners aware that there are many different ways Local Authorities can fund climate action.

SLIDE: How can we fund climate action?

- This slide acts as an introduction to the following slides which outline case studies of how Local Authorities have funded climate action.

SLIDE: Community municipal bonds

- Municipal bonds are a model of public sector crowdfunding, which allow the general public to invest in bonds that deliver social and environmental initiatives.
- Municipal bonds can be used to fund specific projects or refinance existing debt.

Case studies:

- **Swindon Borough Council**
 - Swindon Borough Council, together with Abundance Investment created the UK's first ever Local Authority solar bond in February 2016. This helped to fund a £4.8 million solar farm on council-owned land.
 - Abundance Investment is an online crowdfunding platform which is regulated by the Financial Conduct Authority.
 - The bond raised its £1.8 million target from investors and sold out a month early. The remaining £3 million was invested by the Local Authority.
 - Due to the success of the first initiative, a second bond was launched in November 2016, which was the UK's first ever ISA-eligible solar bond. This helped to fund a £5.4 million solar farm.
 - The second bond raised over £2.3 million from investors. The remaining £3 million was invested by the Local Authority.

- **West Berkshire Council**
 - West Berkshire Council, together with Abundance Investment launched the UK's first ever green bond in 2020.
 - 640 investors each invested an average of approximately £1,500. Over 20% were West Berkshire locals.
 - The bond reached its £1 million target five days early.
 - The bond offered returns of 1.2% annually over a 5 year period.

What have we learnt from the COVID-19 crisis?

- We must listen to the **science** to guide an appropriate response
- Collective, coordinated, rapid action **saves lives**
- Leaders have a key role in **influencing public behaviour** and **driving social change**
- We have a limited window of opportunity to act



Leadership in the climate emergency

- Declaring a climate emergency:
 - should place the climate emergency at the centre of your Local Authority's agenda
 - assigns responsibility to **all** employees to tackle climate change
 - signifies the climate emergency must be at the centre of **all** decision-making processes
 - requires all leaders to be educated in climate-related risks/opportunities
 - assigns responsibility to educate others within your sphere of influence and empower a low carbon culture through behaviour change

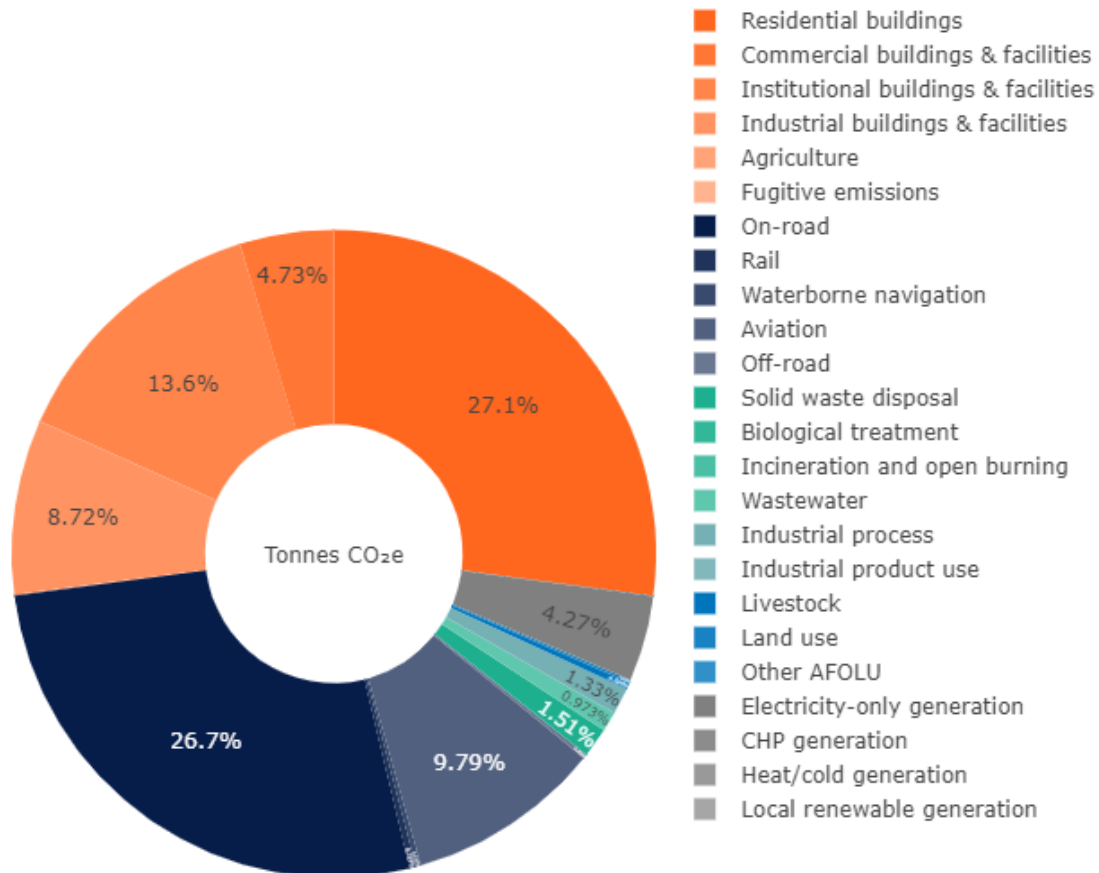

1. Reduce energy demand from buildings
2. Smooth patterns of energy demand
3. Decarbonise heat delivery

Breakout room 3

Change targets:

1. Massively reduce flying
2. Reduce car use, switch to electric vehicles
3. Improve public transport

Breakout room 2

Change targets:

1. Decarbonise power generation
2. New buildings and developments are net zero
3. Incentivise circular economy

Breakout room 4

Change targets:

1. Reduce meat & dairy consumption and food waste
2. Reduce agricultural emissions
3. Capture carbon through natural restoration
